### Homeowner Affidavit

The following information comes directly from the Kentucky Department of Housing, Buildings and Construction, whereas KRS 227A.030 (3) provides an exemption for a homeowner or farm owner to install or repair electrical wiring on their own real property. In order to qualify for the homeowner's exemption the person performing the electrical work must **BOTH OWN AND OCCUPY THE RESIDENCE**. **This exemption does not extend to rental properties and does not exempt you from obtaining the required permit, paying the required inspection fees or obtaining the required inspections.**

By purchasing a homeowner's electrical permit, the homeowner is assuming full liability for the electrical work being performed. Homeowners may purchase a homeowner's electrical permit for new construction provided they already own the real property that the structure will be built on and they will occupy said structure for a minimum of two (2) years.

It is understood and agreed upon that by signing this document, you are certifying that you own the real property and are occupying the premises yourself and that this property is not being used as rental property. A photo I.D. will be required when signing this form. The issuance of the homeowner's permit does not waive the required fees or inspections.
